AND WHEREAS proponents of telecommunication towers are regulated by *Innovation, Science and Economic Development Canada (ISED)*, formerly Industry Canada on behalf of the Government of Canada, and as part of their

approval, ISED requires proponents to consult with land use authorities as provided for in CPC-2-0-03;

AND WHEREAS TELUS has consulted with the Village of Slocan following the CPC-2-0-03 and the Village of Slocan Council have no objection to the proposed telecommunications tower;

AND WHEREAS TELUS has consulted with the public by notifying properties within three times the height of the structure, from the base of the utility pole, and has provided a 30-day period for written public comment;

AND WHEREAS there are no significant land use issues identified by the consultation:

NOW THEREFORE IT BE RESOLVED THAT:

- 1. The CAO be instructed to advise TELUS that:
 - TELUS has satisfactorily completed its consultation with the Village of Slocan;
 - The Village of Slocan is satisfied with TELUS's public consultation process and does not require any further consultation with the public; and
 - c) The Village of Slocan concurs with TELUS's proposal to construct a wireless telecommunications facility provided it is constructed substantially in accordance with the plans submitted to the Village of Slocan.
