

VILLAGE OF SLOCAN **MEETING NOTES – December 11, 2017**

- Colin Moss, on behalf of the Slocan District Chamber of Commerce Health Committee, presented an update on physician recruitment in the Slocan Valley and a synopsis of their 2017 activities.
- Corrie Traenenberg was reappointed as the Slocan representative, to sit on the Slocan Valley Economic Development Commission for the 2018 year.
- Council directed the CAO to file a Community Charter Section 58 Notice of Cancellation with the Land Title Office, removing the 2012 Bylaw Contravention Notice from Title CA6407960, at the property legally described as Parcel A (See KR162354), Block 44, DL 292, Plan 496.
- Council authorized submission of an application to the BC Rural Dividend Program, Project Development Stream, for creation of a Village of Slocan Harold Street North - Conceptual Design Plan, and that the Council support this project through its duration.
- Council resolved to form a Wellness Center Advisory Commission, and staff were directed to put a call-out for practitioner/health-related member recruitment.
- Council resolved to increase water rates by 2.75% (a \$12 increase for residential households) and not to increase garbage rates for the 2018 year.
- Council gave first, second, and third readings to the Village of Slocan Fees & Charges Bylaw No. , 2017 to increase water rates by 2.75%.
- A letter will be sent to the Provincial Government, supporting the District of Sicamous' request to increase awareness and education for the threat of invasive Quagga and Zebra Mussels into BC Lakes.
- Staff will coordinate with WE Graham Community School, for the Mayor, CAO, and PW Supervisor to present to the Grade 5 class on local government, following up on the letters that were received from the students.



Some of the Grade 5 students at WE Graham School made a surprise visit to the Village Office on November 20th, 2017 to hand deliver written letters. The students were curious about the Mayor's duties and operations of the Village. The Mayor, CAO and Public Works Supervisor plan to schedule a presentation to the Grade 5 class in the new year.

WELLNESS CENTER HEALTH COMMITTEE:

The Village is now recruiting volunteer members to sit on a Wellness Center Health Committee of Council. The Committee is limited to 7 members, and will consist of the following representation:

- One member of Council
- Six members at large (practitioners or other healthcare/health-related professionals mandatory).



Are you interested in keeping backyard hens?

The village bylaw states that you may keep hens, to a limit of eight (8). You may not keep a rooster! Please be sure that your hens are properly cooped, they need a warm and clean environment that is rodent resistant. You must be sure that your hens are not running loose or being a nuisance to your neighbours. Coops must be placed correctly in your yard - 3 meters from rear and side lot lines. It is the owners' responsibility to be sure your hens are healthy, if you suspect any illness you must consult a veterinarian. If the diagnosis confirms a communicable disease, the owner must immediately notify the Public Health Dept. of Interior Health and comply with any direction issued by the inspector. For more info.
