VILLAGE OF SLOCAN MEETING NOTES: June 12, 2017

- Chief Financial Officer, Colin McClure, presented the 2016 Annual Report and Statement of Financial Information.
 The 2016 Annual Report and SOFI are available for public inspection at the Village Office during regular business hours. A Special Meeting has been scheduled for Monday, June 26th at 5pm to approve the Report.
- Council approved an application to the FCM Asset Management Program to support implementation of an asset management plan for Slocan. The AMP will include creation of an asset inventory, and assist the Village with generating reports on life expectancy of assets, condition, and replacement costs.
- Council received the report from Michelle West, RDCK GIS Technician, regarding the Slocan Cemetery Ground Penetrating Radar (GPR) survey results. The GPR conducted was Phase 2 of the Cemetery Mapping Project.
- Council approved the request from the Slocan Legion, to plant a Vimy Oak Tree sapling in memory of James R.
 Armstrong, as part of the pending Spirit of Slocan Cenotaph Project, and that the Legion contact the SOS Committee to include on their draft site plan.
- The Mayor will attend and carry a flag at the Silverton July 1st celebrations and parade.
- Council approved a request from the Slocan Valley Seniors Housing Society, to allow an extension for expenditure of their \$10,000 Community Initiatives Program Grant, for construction of a seniors and affordable housing complex in Slocan.
- The Village will advertise for recruitment of volunteer members to sit on an affordable/social/sustainable housing committee, and if there is interest, draft a Terms of Reference for Council approval.
- Report Three: *Economic Strategy and Implementation Plan*, as part of the joint Economic Development Strategy Project, was received, and is now available to the public.
- Council directed staff to place more signage at the public beach, to further advertise that dogs are not permitted.
- The Mayor will be in attendance at the Slocan Valley Historical Society's Historical Walking Tour Interpretive Signage Dedication Ceremony on July 9th at the gazebo.

LEGION:

- Council approved a quote from Robert Inwood, Heritage Design Engineer, for completion of a Heritage Design Plan for the Slocan Legion Hall, to assist with future renovations/retrofits. Council approved an RDCK Community Development Grant to fund the Plan, not to exceed \$5,000.
- Council approved an application to the FCM Green Municipal Fund, to support a Solar Now project and green energy
 initiatives for the Legion Hall, if the project is found feasible for our community.
- Council approved allocating the remaining funds from the \$40,000 Legion Roof Replacement Project budget, to other capital upgrades to the Legion Hall Building.
- Council directed staff to research into the Build Heritage Fund through CBT, and other application grant streams, to complete a potential restoration and retrofit project for the Slocan Legion Hall in 2018.

ZONING & OCP AMENDMENTS:

- As per resolutions 2017/113 and 114 of May 8th, Council will proceed to re-designate the Property Lots 11-13, Block 26, Plan 496, DL 292, as contained in the Slocan OCP and Zoning Bylaws, from Core Commercial to Residential.
- Council will proceed with reducing the minimum site area, as contained in the Village Zoning Bylaw Core Commercial Zone, Section 5.8.2, from 900 square meters to 614 square meters.
- Council will proceed with amending the off-street parking requirement, as contained in the Village Zoning Bylaw, Section 4.21, to allow Core Commercial properties with a maximum site area of 614 square meters to use street frontage for parking, provided that the frontage street is not less than 30.5 meters (100ft) in width. Currently, Harold Street is the only street within the Village that has a minimum road width of 30.5 meters.
- Council will proceed with amending the permitted uses listed in the Mill Industrial Zone, as contained in the Village
 Zoning Bylaw, Section 5.9.1, to remove subsections (b) through (h): accessory residential, accessory retail and
 wholesale, commercial storage, warehouse, contractor office, shop, yard, loading/unloading facility, lumber storage,
 machine shop, and parts manufacture; and further, that Council proceed with amending the wording in the Village OCP,
 Section 8.0, to properly reflect the removal of some permitted uses in this zone.
- Council gave first and second readings to the Village of Slocan Zoning Amendment Bylaw ____, 2017 and the Village of Slocan OCP Amendment Bylaw ____, 2017.
- Council scheduled a Public Hearing concerning the proposed amendments to the Zoning and OCP Amendment Bylaws for July 10th at 5:00pm. Written submissions regarding the amendments will be received up until 4pm on July 6th.

Property Taxes are due July 4th. Please keep in mind that the office will be closed on Monday July 3rd for the Canada Day Holiday. Utility & Tax Payments can be made at any time of year and will be applied to your account as a credit/prepayment. You can come into the Village Office and make payments with a debit card, cash, or cheque, or if you bank with a Credit Union/BMO, payments can be made online! If paying online, please use your account number/roll number to register.

NOTICE OF PUBLIC HEARING: Monday, July 10th at 5:00 pm

Notice is hereby given that a Public Hearing will be held Monday, July 10th, 2017 at 5:00 pm
At the Village of Slocan, Council Chambers, 503 Slocan Street, Slocan BC

The purpose of the public hearing is to consider amendments to the *Village of Slocan Zoning Bylaw 633* and the *Village of Slocan Official Community Plan Bylaw 616*. The Zoning Amendment, if adopted, will:

- Re-designate Lots 11-13, Block 26, DL292, Plan496, from 'Core Commercial' to 'Residential';
- Decrease the Core Commercial minimum site area requirement from 900 square meters to 614 square meters:
- Allow Core Commercial properties, with a maximum site area of 614m², to use street frontage for parking, provided that the frontage street is not less than 30.5m in width;
- Limit the permitted uses in the (M1) Mill Industrial Zone by removing the following use subsections: accessory residential, accessory retail and wholesale, commercial storage, warehouse, contractor office, shop, yard, loading/unloading facility, lumber storage, machine shop, and parts manufacture.

The Official Community Plan Amendment, if adopted, will:


Amend the wording in Section 8.0 – Industrial Objectives & Policies, to properly reflect the
permitted uses in the Zoning Bylaw Mill Industrial Zone, and express support for future mixed-use
development, subject to a planning process and rezoning application.

Background information on the proposed amendments and bylaws may be inspected at the Village Office during regular business hours (9am-4pm, Monday-Thursday). Written submission on the matters contained herein will be received until 4pm on Thursday, July 6th, 2017.
