VILLAGE OF SLOCAN MEETING NOTES:

May 11, 2020:

- CFO Colin McClure presented the 2020 Budget.
- Council approved the draft Licence of Occupation (Right of Way Access Agreement) with CBBC outlining the terms for installation, maintenance, and operation of the fibre equipment to be installed within the Village of Slocan.
- Approval for Christina Knight, to renew her Licence to Occupy the Expo Park upper bench area for the purpose of hosting a Saturday Market during the months of June, July and August, provided that all local, regional, provincial and federal COVID-19
- The Village of Slocan Financial Plan (2020-2024) Bylaw No.676 and the Tax Rate Bylaw No. 677, 2020 were adopted.
- Council approved acceptance of the \$13,000 CMHC Contribution Amount, and \$16,000 CMHC Seed Loan Amount, for assistance with the affordable housing pre-development project costs.
- Council staff directed to sign and complete the Letter of Consent for the RDCK Electoral Areas E & F and Slocan Valley Transit Service Amendment Bylaw No. 2709, 2020.
- The CIP/AAP 2019 Grant extension request was approved for WEGCSS for their Afterschool Program Van Service.
- Ron Leblanc, Regional Economic Development Coordinator, provided a report on the Slocan Valley Development Partnership progress for April 2020.
- Councillor Van Bynen's verbal report on the Waterfront, Councillor Pelletier's verbal report on the WEGCSS Food Bank Garden, and the Mayor's verbal May Report were presented for information.
- Barbara Mulcahy inquired/commented on the following: Harold Street Detailed Design Plan details; CBT Public Art Grant location of installation; Clarification on Tax Rate Bylaw; Waterfront Development Beautification.
- The Slocan Valley Economic Development Progress Report for May 2020, provided by R. Leblanc, was received.

June 1, 2020

Council approved the CBT Community Initiatives CIP/AAP Grant Funding Program funding allocations for 2020.

- Christina Yahn and Justin Werner of White Pine Mountain Apiary presented to Council on their Martens Road honeybee farm, and explained the effects of pesticide poisoning on bees. The information was shared to raise awareness to Slocan residents, and express the importance of keeping these pollinators safe.
- The Main Street Paving Proposal and corresponding information, provided by the CAO, was received.
- The Affordable Housing Project update, provided by the CAO, was received.
- The Slocan Legion Hall Heritage Exterior Restoration Project update, provided by the CAO, was received.
- The Slocan Valley Wildfire Resilience Program update, provided by SIFCo, was received.
- The update received from the West Kootenay EcoSociety, regarding the 100% Renewable Kootenay Plan, was received.
- The Slocan Valley Economic Development Progress Report for June 2020, provided by R. Leblanc, was received.
- Council will send a letter to Stick & Stone Cannabis Co, and the Association of Canadian Cannabis Retailers (ACCRES), endorsing their letter of support to the Solicitor General, petitioning the BC Gov't to modify cannabis retail regulations during COVID-19.
- Staff will investigate traffic signage for Main Street, including speed zone signage/directional signage for boat traffic.

July 13, 2020

- CFO Colin McClure presented the 2019 Annual Report and Statement of Financial Information. The documents are available for inspection at the Village and online. Council will give final consideration at their August 10th meeting.
- Nicol Berinstein, Architect, and Bernie Penner, Pennco Engineering, presented to Council a summary of the encroachment application proposed for 501 Harold Street. Council approved the application, and authorized staff to execute a long-term Licence of Occupation to encroach on municipal right-of-way, for the purpose of providing an extension and upgrades to the existing structure and its uses, provided that the \$500 application fee be paid, that compensation be charged annually, an amount of 10% of the assessed value of the leased land, and that the owner/developer be required to adhere to all bylaws, legislation, plans, and construct to WorkSafeBC standards, including installation of safety fencing and the directing of traffic, if applicable, during
- Councillors Pelletier and Buller will attend the 2020 UBCM Virtual Convention alongside Mayor Lunn.
- Council approved the Rail Trail Society's CIP/AAP extension request for their 2019 vegetation management project.
- Council will send a letter to CBT in support of the Legion's submission of an Expression of Interest, for heating equipment upgrades at the Legion Hall. Council will contribute \$6,250 towards the project, if approved.
- CKISS will set up an outreach booth at the Slocan Waterfront on July 25th to educate watercraft enthusiasts about the simple actions that can be taken to protect our water from the harmful impacts of invasive species.
- Council approved the Historical Society funding request for \$175, for their archives upgrade project.
- Council directed staff to research into drafting a 5G policy for Slocan.
- The Slocan Valley Economic Development Progress Report for July 2020, provided by R. Leblanc, was received.
- Council gave first and second readings to the Zoning Amendment and OCP Amendment Bylaws, to support re-designation of Village-owned property (Lots 1-5 and 18-20, Block 43) to Multi-Family Residential, for the purpose of constructing an affordable housing complex. Council also gave first and second readings to the Road Closure & Dedication Removal Bylaw, closing off a portion of Block 43 laneway. A public hearing has been scheduled for August 10th at 6pm at the Legion Hall, concerning the proposed bylaws.

NOTICE:

WATER CONSERVATION MEASURES

Effective immediately: JULY 15th 2020

Sprinkling permitted daily between the hours of:

7:00 a.m. to 9:00 a.m. And 6:00 p.m. to 8:00 p.m.

During the spring and summer seasons, daily residential water use can double over winter consumption primarily because of lawn and garden watering and car washing. Our residential water is gravity fed from a 255,000 gallon reservoir on Gwillim Creek, and the water plant has to pump water through the filters, then up to the reservoir. During freshet the creek NTU's are running high; this will cause water production to decrease and the demand is higher than the plant can produce. If sprinkling is kept within the permitted hours, this will give the reservoir a chance to recover and will give operators time to do plant maintenance.

DO NOT over-water your lawn! To stay healthy, most lawns need 2.5 cm of water (equal to 1 hour of sprinkling) per week.

Please ensure that water does not over-spray onto sidewalks, driveways or roads.

The Slocan Recycling Depot was closed June 29th to prepare for the new recycling program, re-opening soon! This depot will be receiving new recycling containers and staff in order to join the

RecycleBC Depot program. Once it launches under the new program this depot will operate as a core depot and accept all materials collected by RecycleBC. Users will be able to access the Slocan depot during the following hours: 9:00am to 3:00pm Tuesday, Thursday and Saturday.

Changes Coming to RDCK recycling Depots!

Throughout this summer recycling depots in the RDCK will begin service with RecycleBC

Changes include new collection containers, new hours of depot operation and materials accepted for recycling. RecycleBc's mandate covers residential packaging and printed paper. This means material that was not packaging or printed paper or from commercial operations will not be accepted in the RecycleBC system.

With social distancing requirements and reduced hours it is important to sort your recycling at home to make visits to the depot easier and quicker. The infographic below shows categories, those coloured the same can be grouped together. Residents will now be able to recycle plastic bags, Styrofoam, Tetra Paks and more!
