To the Slocan Valley Historical Society for receiving a \$500,000 grant to complete the **Merriwake Interpretive Centre in Slocan!**

An important piece of Japanese-Canadian history will be preserved in the Slocan Valley thanks to a \$500,000 grant from Heritage BC. The funds will support construction of the Merriwake Interpretive Centre in Slocan. The building will shelter the Merriwake, a 31-foot fishing boat believed to be the last of its kind in Canada. "This injection of funds will allow us not only to showcase the restored vessel, but to tell part of the larger story of the Japanese-Canadian internment," says Slocan Valley Historical Society vice-president Anitra Winje. "We are ecstatic to receive this support".

FRIENDLY REMINDER - Garbage

GARBAGE DAY IS TUESDAY ALL GARBAGE MUST BE OUT BY 9AM FOR PICK UP!

Please note that there is a weight restriction on bags (22 lbs/10 kg max). Bags over the limit will not be collected. All bags must be securely sealed and preferably in a garbage can with a secure lid to keep animals out. Any damaged bags must be

cleaned up by the homeowner. Garbage tags are available at the Village Office for \$3.00/each if you wish to put out an extra bag. These tags are only good for curb side pick up and are not transferable for the RDCK transfer station (Dump).

VILLAGE OF SLOCAN MEETING NOTES

February 8th - Regular Meeting

- Council approved in principle a request from the Outriders Association, to construct a perimeter fence on the SVOA lands, and that details of the materials/site plan be provided to Council.
- A letter will be sent to the Rural Alternatives Research & Training Society (RARTS), supporting their application to the Columbia Basin Trust Outdoor Revitalization Grant Program, for improvements to the Vallican Whole Community Center grounds.
- A letter will be sent to the Ministry of Health, Ministry of Mental Health and Addictions & Health Authorities, including Northern Health and Interior Health, and local MLA, supporting the BC Schizophrenia Society's (BCSS) efforts to provide care for mental illnesses to families, through programs and services.
- The Healthy Community Society will be invited to present to Council on their composting programs.
- A letter will be sent to the RDCK, requesting to consider lowering transit rates during review of the regional transit
- Council renewed its Financial Services Contract with the City of Nelson for a further term of 3 years.
- Council submitted an application to BC Housing for the January 15th funding deadline for the Slocan Affordable Housing Project, and staff were directed to prepare an information package on the Housing Project and a Public Opinion Survey, to better gauge the support of the community, to be completed by March 31, 2021; and that Council will decide if the Project will move forward after reviewing the results.

March 8th – Regular Meeting

- Chris Johnson, RDCK Manager of Community Sustainability, presented to Council on the RDCK Emergency Program, summarizing 2020 and 2021 programs and events.
- Donna Wilchynski and Tyler Rice presented a summary of the West Kootenay Boundary Investment Co-op, including who they are, what they do, and how they support local businesses in the Kootenays.
- Council approved the Development Variance Permit application to vary the residential zone accessory structure height requirements as established in the Village of Slocan Zoning Bylaw, for construction of an accessory residential unit, from 15 feet to 18 feet, for the property legally described as Parcel A, Block 23, Plan 496, DL 292, PID: 023-771-615,
- A report was received from the CAO, updating Council on the Paving Project Proposal. Due to a large number of applicants, the grant application was unsuccessful. Council directed staff to consult with the CFO to determine if the paving project could be funded from internal sources.
- The CAO provided a report on electronic recycling. Council directed staff to facilitate placement of an electronic recycling bin at the Village during clean-up week.
- Council approved an application submission to the Healthy Communities Initiative, for funding to resurface the tennis court with a Flex-Court Canada sports surface.
- Correspondence was received from TELUS, requesting a letter of support for their Universal Broadband Fund Application. Council asked that TELUS provide more information on the project scope and timeline before making a
- A letter was received from the Rural Alternatives Research & Training Society (RARTS), requesting a representative of the Village to come to a future RARTS meeting to present details of the Affordable Housing Project. Councillor Pelletier will attend the RARTS June meeting to make a presentation.
- Council directed staff to schedule a meeting with Council and the Slocan Valley Community Complex Society, to discuss their request for the Village to provide water outside the boundary, to service up to twenty lots south of the cemetery.
- Council approved use of the COVID-19 Safe Restart Grant funds for installation of laundry services in the Wellness Center; and further, that the grant also be used to support reopening the Fitness Center, including the hiring of staff persons if needed, and that a draft budget for reopening/staff costs be provided to Council at the next meeting.
- Council appointed Slocan Fire Department representative, Adriana Burton, to the Slocan Fitness Center Advisory Commission, and Rory Lindsay was appointed to the Owl Walk Advisory Commission.

HOMEOWNER GRANT APPLICATION

If you qualify for the home owner grant, you must apply each year to receive it. You must apply every year because the previous year's information may be out of date if your residential circumstance has changed. This may affect your qualifications for the grant.

Starting in 2021, residents in municipalities no longer apply for the home owner grant through their municipal office. Everyone now applies directly to the province using a new online system that's easy to use and will process applications faster. When you apply, we'll need your social insurance number to verify your eligibility.

Get ready to apply:

- 1. Wait to receive your property tax notice in the mail. This usually happens around May.
- 2. Keep your property tax notice on hand. It has important numbers you'll need to apply.
- 3. Apply online at: www.gov.bc.ca/homeownergrant Your information will be safe and secure when you apply online. It only takes a few minutes and is faster than calling.
- 4. If you're unable to apply online, call us at 1-888-355-2700 for assistance.

Apply for the home owner grant when you receive your property tax notice. You may apply early, but applications are processed after tax notices are mailed out.

*Be sure to apply before your property tax due date to avoid late payment penalties.
