- b) That effective January 1st, 2023 and every January 1st thereafter, mileage resulting from the use of personal vehicles for Village business be reimbursed at the per kilometre rate set by the Canada Revenue Agency at January 1st of the current year; and
- c) That effective April 1st, 2023 and every April 1st thereafter, meal allowances shall be compensated at the rates set by the National Joint Council at April 1st of the current year. Meal allowances are only granted for meals required during travel that are not provided by a meeting or conference.
