Energy Step Code changes for new home construction - Step Code 3 required starting May 1...

the Regional District of Central Kootenay (RDCK), in accordance with the BC Building Code (BCBC), will require every new Part 9 building (residential and small commercial/industrial) to meet Step 3 of BC's Energy Step Code.

The change will ensure new buildings are 20% more energy efficient than an equivalent building constructed to the 2018 Building Code. The move follows the BC Energy Step Code – a standard based on a series of energy efficiency performance targets, or "steps", for new construction and major renovations in the province. The steps 1 to 5 represent increasing levels of performance related to building energy efficiency.

VILLAGE OF SLOCAN MEETING NOTES – April 2023

April 4, 2023 - Special Redi Grant Public Input Meeting

- Those who applied to the Village of Slocan through the 2023 Resident Directed (ReDi) Grant Program, were invited to attend the meeting to provide a brief 5-minute on their application.

April 11, 2023 – Regular Meeting

- Dave Fredrickson, representing the newly-formed *Slocan and Area Trail Society*, attended the meeting to provide information to Council on the Society, their mandate, and proposed project to preserve local back-country access by maintaining existing roads and trails.
- Correspondence was received from Corinne Funk, requesting support for an Earth Day garbage clean-up on Friday, April 21st. Council approved Village disposal of garbage bags collected from the event (to be brought to the Public Works yard), as requested.
- Council approved a \$1,500 grant from the RDCK Community Development Fund, for the Slocan and Area Trail Society's (SATS) initiative to preserve back-country road access, maintain existing roads and trails, and develop new trails for the community for non-commercial use.
- Council approved the request from Lisa Parente of *Treehuggers Retreats and Events*, for use of the Slocan Beach to host a festival on the Slocan beach on Saturday, July 15, 2023 pending submission of a completed Special Events Application, proof of insurance, and all other Village requirements. July 14th and 16th festival days were approved *in principle*, pending an update from the organizers on their funding campaign and start/end times, by the June 12th Council meeting. Outdoor live music on Saturday, July 15th, 2023 was approved to be extended to 11:00pm, and Council wished to remind organizers that if a beer garden at the festival is desired, a separate request to Council with all pertinent information, is required.
- The Village of Slocan Fees & Charges Amendment Bylaw No. 704, 2023 was adopted.
- Staff were directed to put a call-out to charitable/non-profit organizations in Slocan [Village] for eligible projects and initiatives meeting the criteria for the FortisBC Community Giving Grant. The submissions will be sent to FortisBC by the deadline of May 14th, 2023.

April 17, 2023 - Special Budget Presentation

- Nathan Russ, Chief Financial Officer, provided a presentation to Council and the public on the Village's proposed budget and 2023 Financial Plan.
- The Village of Slocan Financial Plan (2023-2027) Bylaw and Annual Tax Rate Bylaw 2023 were given three readings.

April 18, 2023 - Special Redi Grant Funding Allocation Meeting

- Council held a special meeting to allocate funds for the 2023 ReDi Grant Program.

WE NEED YOUR HELP!

Dear followers and supporters,

The BC Rural Health Network has been active in the media lately and we anticipate that this will increase in 2023. We are often asked for real life stories on how living rurally impacts you, your health and your wallet!

We recently did a round of media in regards to out of pocket expenses and the inequity in the cost of receiving care for rural residents. This campaign will continue into 2023 and a formal position paper is currently being created by our Implementation Committee. During this latest round of media we were asked to bring residents stories forward and although we had several situations we were aware of, people were not comfortable disclosing information to the press or were just not comfortable with public speaking or media interviews.

We are seeking stories and people willing to share them when we have a media opportunity. If you have an experience you are willing to share with us and you are willing to be interviewed when we have a media opportunity, we would be most grateful! Some of the things we would like to hear about:

- Travel challenges e.g. distance to care, weather impacts, public transport challenges, cost of travel, ability to travel in pain and any other travel related impacts on your health.
- End of life care e.g. inability to age in place, lack of supportive services, travel to support family members forced to seek care out of town.
- Loss of income challenges e.g. taking time off work to seek care, impacts on your life due to illness, impacts on your family, impacts on you supporting others seeking care.
- Child care challenges e.g. how child raising is impacted when seeking care, challenges in getting care for your children when living rurally,
- Maternity care challenges e.g. how living rurally has impacted having a family and giving birth, the costs, the health risks, the distance, the time away from home etc.
- Any other impactful stories that highlight the concerns of living rurally and getting basic health care services.
