BYLAW NO. ___, 2020

BEING A BYLAW TO AMEND ZONING BYLAW NO. 633

WHEREAS the Council of the Village of Slocan deems it desirable to amend the "*Village of Slocan Zoning Bylaw No. 633, 2013*", to re-zone a portion of Village-owned land from M1: Mill Industrial Zone to P1: Parks, Open Space & Institutional Zone, within the Village of Slocan.

NOW THEREFORE, the Council of the Village of Slocan in open meeting assembled hereby ENACTS AS FOLLOWS:

1. That the northerly portion of property situated within Lot 1, Plan NEP 8719, District Lot 292, Kootenay Land District, PID: 008-206-031, and the section of Slocan Lake Foreshore abutting the north edge of Lot 1, Plan NEP8719, be rezoned from "M1: Mill Industrial Zone" to "P1: Parks, Open Space & Institutional Zone", as appended hereto and marked as Schedule 'A' to this Bylaw.
2. That Schedule "B" Zoning Map of Zoning Bylaw No. 633, 2013 be redrawn to change Zoning Designation of the northerly portion of property situated within Lot 1, Plan NEP 8719, District Lot 292, Kootenay Land District, PID: 008-206-031, and the section of Slocan Lake Foreshore abutting the north edge of Lot 1, Plan NEP4719, to "P1: Parks, Open Space & Institutional Zone".
3. This Bylaw may be cited as the "**VILLAGE OF SLOCAN ZONING AMENDMENT BYLAW No. ___, 2020.**"

BEING A BYLAW TO AMEND OFFICIAL COMMUNITY PLAN BYLAW NO. 616

WHEREAS the Council of the Village of Slocan deems it desirable to amend the "*Village of Slocan Official Community Plan Bylaw No. 616, 2011*", to amend the Schedule 'B' Land Use Designation Map.

NOW THEREFORE, the Council of the Village of Slocan in open meeting assembled hereby ENACTS AS FOLLOWS:

1. That the Village of Slocan Official Community Plan Bylaw No. 616, 2011 Schedule 'B' Land Use Designation Map be redrawn to change designation of the northerly portion of property situated within Lot 1, Plan NEP 8719, District Lot 292, Kootenay Land District, PID: 008-206-031, and the section of Slocan Lake Foreshore abutting the north edge of Lot 1, Plan NEP4719, from "M1: Mill Industrial Zone" to "P1: Parks, Open Space & Institutional Zone", as appended hereto and marked as Schedule 'A' to this Bylaw.
2. This Bylaw may be cited as "**VILLAGE OF SLOCAN OFFICIAL COMMUNITY PLAN AMENDMENT BYLAW NO. ____, 2020**".

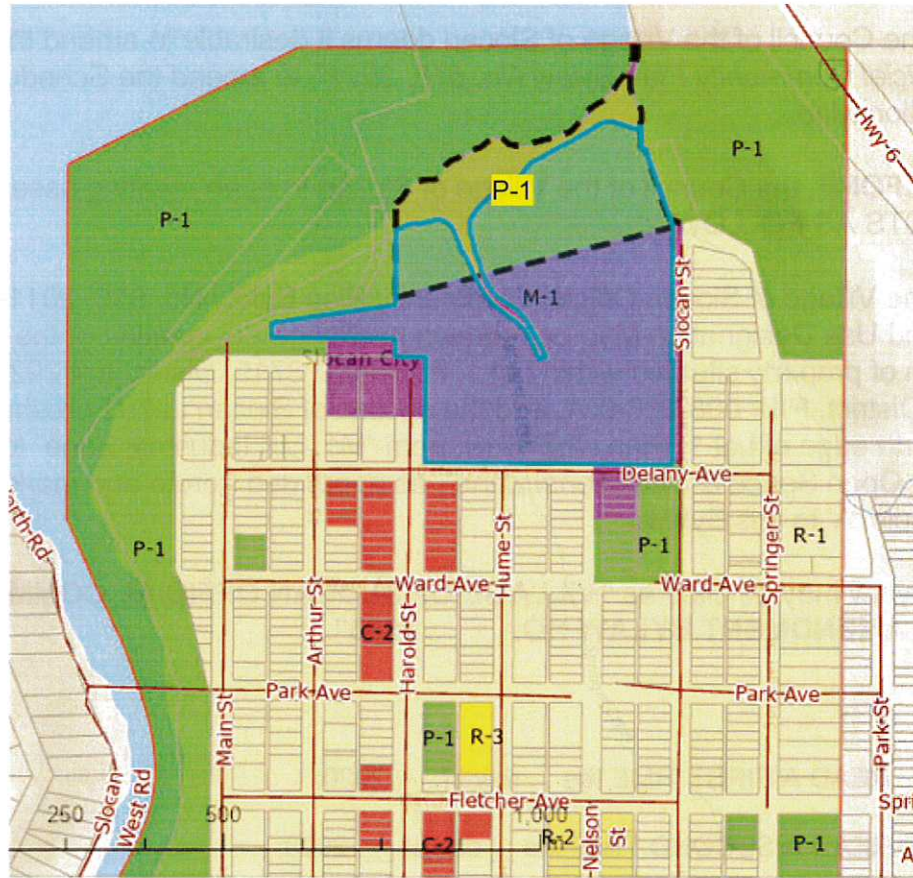
